The first item is to cover costs of purchasing and maintaining general and marine liability insurance and the second item is to cover costs of purchasing and maintaining a new club web site that would allow for better online access to club resources, more efficient club management, facilitate use of electronic payments, and provide the ability for social networking. The Board has also taken action and is recommending several amendments to the Bylaws. The Bylaws changes are primarily administrative in nature and intended to clarify the language for improved interpretation. One of the proposed Bylaws changes relates to member classification to require an Active Member to have ownership in a cruising vessel while an Associate Member may own a non cruising vessel. Please see the Notice of Proposed Bylaws Amendments section for more detailed information on all the recommendations.

We are still in need of several cruise captains for upcoming cruises. Thanks to Robin Haley and Mike Goodman for volunteering to lead the Everett cruise. Please contact Jon Edwards if you are interested in leading a cruise.

Here is the Corned beef and Chris's homemade Irish Creams recipe's from the St. Patty's Day Cruise

Corned Beef

Traeger Wood Pellet Grills

Smoked Corned Beef Brisket

1 corned beef brisket flat, about 3 pounds with a fat cap

1 -8 ounce bottle Traeger Apricot Barbecue Sauce

1/4 cup Dijon style mustard

Start the Traeger on Smoke then set the temperature to 275

Put corned beef on the grill fat side up and cook for 2 hours.

Combine the barbecue sauce and mustard (1 -8 oz bottle to 1/4 cup mustard)

Pour half the sauce in the bottom of a disposable aluminum foil pan

Place brisket in the pan fat side up

Pour remainder of sauce over top of brisket

Cover the pan with foil

Cook for 2 more hours or until 185 degrees

Let rest for 15 to 20 minutes

slice across the grain and serve

Baileys Irish Cream

In a blender

Combine 3 eggs (Egg Beaters)

1 cup whipping cream

1 can sweetened condensed milk

Add 2 tablespoons of Hershey's chocolate syrup

2 tablespoons of vanilla extract

1 tablespoon of instant espresso powder
blend for 30 seconds on low

Add 1 1/3 cups of Irish whiskey

1/2 cup of water

Blend on low for 30 seconds

Keep refrigerated

No idea how long it keeps, we drink it before going bad is an issue.

NOTICE - Recommendation to Change Membership Dues

In accordance with **Article V: Application Fees, Dues and Assessments, Section 1** states "Annual membership dues rates will be established from time to time based on a recommendation by the Board of Trustees and approved by club members." **Section 2** states "A majority vote of at least two-thirds of those members eligible to vote and attending a meeting for this purpose will be required for approval of the recommendation."

The Board of Trustees has approved two recommendations to put before the membership for approval. Both recommendations will result in an increase to the annual membership dues as described below:

Recommendation 1

This recommendation is to replace the existing website with a new platform on commercially available software that has many integrated features to support a club like RHYC. The new platform would provide each member with their own username and password to log in and view member-only content, an online membership database, member profile, event calendar, photo pages, document library and public and private web pages. The website platform also contains many other features that could optionally be implemented in the future such as credit card

payment, on-line cruise signups, and more social media access. For additional information on the platform capabilities, please see the advanced notice published in the February newsletter. For those members that do not have Internet access, the club would still mail club communications. Jon Edwards will be making a presentation on the platform at the Business Meeting and will be prepared to answer any questions members may have.

The costs to purchase the software platform, ongoing maintenance and fees for individual member access will be paid through an increase in the annual membership dues of \$10 for active and associate members. In accordance with the Bylaws, Senior members will pay half the active membership increase.

Recommendation 2

The Board of Trustees is recommending the purchase of liability insurance for the club. This recommendation partially came to light when the Port of Everett mandated we have club coverage in order to rent space for our meetings last year. The Board investigated and decided it is in the best interest of the club to purchase yearly insurance policies for general and marine liability rather than for individual events. The requirements for liability insurance appears to be increasing at many venues including marinas and rental facilities that the club typically uses for our events. By purchasing yearly policies we will benefit from reduced costs from individual policies and the club will have the insurance in place and readily available to the cruise teams. Having insurance policies in place is good management practice and will provide the club with liability coverage in the event a claim is made against us.

The cost to purchase liability insurance will be paid through and increase in the annual membership dues of \$15 for active and associate members. In accordance with the Bylaws, Senior members will pay half the active membership increase.

In order to implement the above recommendations in a timely manor, the Board of Trustees has included in the proposed 2015 budget, costs for the web platform upgrade and liability insurance. Since any dues increase would become effective in 2016, the initial implementation costs in 2015 would come from available cash reserves.

NOTICE of Proposed Bylaws Amendments

Article XIII: Amendments, Paragraph A states "Proposals for amendment to these Bylaws may be presented by majority vote of the Board of Trustees or by a petition signed by 10% of the voting membership." Paragraph B states "To be accepted amendment proposals require and vote of two-thirds o(2/3rds) of members present and voting at an Annual Meeting, Regular Business Meeting or a Special Meeting of the membership called for that purpose."

The Board of Trustees has approved the following proposals for amendments to the Bylaws and is presenting them to the membership for approval:

Article II: MEMBERSHIP, Section 2

The current Bylaws statement for being an Active member says that if you own a boat you are only allowed to join RHYC as an Active member. There is no allowance to join as an Associate member even if you only own a 10' aluminum fishing skiff because the skiff is considered a boat.

The Board felt the Bylaws intention is the boat is used for cruising. Additionally if you own a boat in Florida, but not in Seattle, you are not eligible to be an Associate member because you own a boat. Consequently the Board has proposed to amend the wording (shown in red) for Active member eligibility as follows.

A. - ACTIVE MEMBERSHIP: Active membership will consist of individuals who have bona fide ownership interest in any **Salish Sea based cruising** vessel propelled by a regularly installed engine or by sails on a fixed mast. Active members who dispose of their boat may retain active membership, or may request a change to Associate membership. Total Active Membership shall be limited to Two Hundred (200) members.

With this amendment to the Active member wording, the Board has proposed to amend the Associate Member eligibility section wording to:

C. - ASSOCIATE MEMBERSHIP: Persons without boat ownership **as required for active membership**, may be **accepted as an associate member**. Associate members shall be entitled to the privileges of **our Club sponsored** activities but shall not be eligible to **fly the Club Burgee on a vessel, use outstation/reciprocal moorage offerings**, or vote **on club business**. Associate members shall pay reduced initiation fees and dues as determined by the Board

Based on approval of amendments above, the section below must be amended to conform.

ARTICLE II: MEMBERSHIP, Section 3

Change in membership classification.

If a member in good standing wishes to change membership classification he/she must submit a written request to the Board of Trustees through the Membership Chairman (Vice Commodore). This request/application may be by letter or on their annual renewal form. If a member changes status midyear, there will be no reduction or refunding of any dues for that year.

A. - Associate to Active:

An Associate member, who obtains a bona fide interest in any **Salish Sea based cruising** vessel propelled by a regularly installed engine or by sails on a fixed mast, may apply for Active membership classification through the normal application process, with the following additions/exceptions to that process.

ARTICLE VII: GOVERNANCE, Section 3, Subsection F

In subsection F that outlines the duties of the Treasurer, the Board has determined the language does not directly reflect the purpose for the clubs investment account. The Board has proposed the following amendments to paragraph 8:

8. – The Treasurer shall maintain the special account known as the Investment Account to **hold funds as security** to provide for **acquiring and maintaining** the Club Outstations and/or any other properties or physical facilities leased, rented to, or owned by the Club. The Investment Account may be increased from time to time at the discretion of the Board of Trustees, using any net operating funds not needed for other Club business.

ARTICLE V: APPLICATION FEES, DUES AND ASSESSMENTS

Board review of the Bylaws section related to annual dues showed that the current requirement to publish the rate for Club dues in the Anchor Watch may not be in the best interest of the club since the Anchor Watch is a publicly available document while posting dues rates on the application and renewal forms is a more efficient and secure practice. The Board proposes the following amendment:

Section 1

Annual membership dues rates will be established from time to time based on a recommendation by the Board of Trustees and approved by club members. These rates will be published to the membership each year **on the membership renewal form** and on Club Application forms.

VESSEL SAFETY CHECKS

**Guilty Pleasures Cruise
Everett Marina
April 18, 2015**

Vessel Safety Checks will once again be offered at our annual business meeting cruise in April at the Everett Marina. We will begin checking boats Saturday, 18 April, from 1000HRS till 1500 HRS or the start of the business meeting whichever comes first.

The VSC Decals awarded are the same ones that the Guard Auxiliary awards. While displaying a current VSC Decal on your boat doesn't guarantee that you won't be boarded by the Coast Guard, it may cause them to "pass you by" while cruising.

Items that most often typically cause a boat not to pass this check are: **out of date flares; inoperative running lights; inoperative horns and no copy of the "Navigation Rules" (boats 39.4' or greater) onboard.** Checking a boat takes approximately 20-30 minutes.

As in the past, boats will be checked on a first come first served basis as determined by registration receipt. Please contact Harry Johnson at formrtiger@msn.com to register your boat or for any questions concerning the VSC program.

We will start to anchor boats on Wednesday evening, April 29th, so come out when you can. **IMPORTANT:** Plan to **arrive no later than Thurs. evening** to ensure a spot next to other RHYC club members as it becomes less likely to squeeze boats in Friday and next door to impossible on Saturday. **All attending boats must have both a bow and stern anchor.**

Wednesday – Thursday April 29th and 30th: Slip on in – we will help you get anchored and rafted up. If you have to work, consider bringing your boat out in the evening and leaving it. We will have people in the area the whole time and would probably drop you off and pick you up from shore as needed.

Friday May 1st: Sit back, relax, and spend the day on your boat watching the world go by as others arrive from a hard days work. We'll go boat to boat for no-host goodies, refreshments, and socializing.

Saturday May 2nd: Breakfast on your own or share with others. Get set for the Crew races, watch the action, and visit with friends. Later, cheer our RHYC Bridge as they parade by. Followed by the annual decorated boat parade – this year's theme is "Myth's & Monsters". Meals are on your own but many of us BBQ and share.



Sunday May 3rd: Breakfast on your own or share with others, relax and visit. With a little planning you can pull out anytime with great memories of a laid back weekend. What could be easier!
