Deadline for next newsletter..... April 10



For many of us this has been a stressful past month. I am sure you have similar concerns regarding health and wellbeing as I have had. That being said, keeping stress to a minimum is the most important thing you can do for your nervous system which is why we boat! We will continue to have our monthly cruises and hope to see you there.

This AW has a list of bylaws changes that your board is proposing. Please read below then read through the proposed changes.

We need to clarify the wording regarding the secretary duties since the bylaws were written before we had a website.

Verna Maruska has stepped in to be our AW editor. In the bylaws there is no provision to allow us to bring on a non-board member to do this job so we are proposing changes to allow us to continue to have Verna do this or another club member who would be interested in doing this in the future.

We need to clarify some wording regarding special meetings.

The board and myself have been hard at work looking at changes that need to occur to stabilize and ensure that RHYC continues to be around for many years to come. The most important concern has been fiscal. Over the past 9 years we have been seeing a steady decline in the number of members (29% decrease since 2011). As a recreational boating club in the Puget Sound, what we are seeing is not unique to us. We maintain 4 outstations, a reciprocal, a website as well as the daily business of the club. There are costs associated with all of this and those costs are rising annually.

We are proposing that the board be able to increase dues up to 5% annually, without needing a membership vote, so that we may continue to tackle those changes as they come up but not be delayed by 6 months at a time until we have a business meeting in November or April.

We also took a hard look at our dues and our member classifications and we are proposing to remove the Senior membership designation. By doing this it will add almost \$5000 to our budget for 2021.

Finally, we will be proposing an increase in dues across the board. In the 4 years I have been on the board, we have needed to request \$5000 out of the investment fund every year in order to maintain ourselves in the black. Our investment fund, no matter how we argue it, does not exist in order to manage our monthly expenses. If it did it would be gone within a few years. The club needs to be able to manage its monthly expenses and set a budget annually with predictable income.

Please feel free to communicate with me or any of the board members if you have any questions or concerns. We will be bringing these bylaws changes up at the April business meeting.

The financial statements have been reconciled thru January 31 and presented to the board at our monthly meeting on February 4. As part of the preparation of the financial statements, our bank account with US Bank has been reconciled. You can find a copy of the financial statements on the website under the treasurer section of the Documents tab.

The financial statements and presentation of our 2020 budget will be available at the annual meeting on Saturday April 25th at 2:00 at the Sons of Norway Hall in Poulsbo. Be sure to plan on attending the annual business meeting as this is the opportunity for you to share your thoughts on the club and club operations.

A message from Ken & Julie

For over a year now, Julie has been talking and walking a bit slow. In September, she was diagnosed with ALS also known as motor neuron disease (MND) or Lou Gehrig's disease. There are two forms of the disease, limb onset and bulbar onset. The difference is whether is starts in your hands and feet or in your mouth and throat. Julie has bulbar onset. She has lost most of her ability to talk and has a hard time swallowing. I tell her she sounds a lot like the Swedish chef from Sesame Street. She has a Tobii speech assistant. She also has apps for her IPad and her cell phone, a boogie board electronic writer and also pen and paper to help her express herself. The Boogie Board electronic writer is very cute and only \$20.

She still gets around pretty well, especially on flat ground. She does fine going down stairs but I don't want her doing it alone. She needs assistance going up stairs. We have a manual transport wheelchair (4 smaller wheels) that we got from the ALS Association. She fell a couple times on one of the cruises so I sentenced her to the chair on longer distances for speed and safety. She rides and I push. She is something of a speed demon though. She goes weaving through traffic passing people left and right. Sometimes going downhill I have to run to catch up with her.

We've been going to the ALS clinic at Virginia Mason hospital in Seattle. There is nothing in Bellingham. They hold the clinic on Wednesdays. We go every other month. It is interesting how they handle it. They put you in a room for 4 hours and 8 or more doctors, nurses and therapists rotate in and out of the room. She sees a neurologist, a pulmonologist, a rehab doctor, physical therapy, occupational therapy, a speech pathologist, a nutritionist, a so-cial worker and a few others, all without leaving the room. There is a monthly support group in Bellingham.

Julie's spirits remain good. She finds a lot to laugh at. We still give each other a bad time.

We've gone on 4 cruises over the last 14 months, one on a 50 foot catamaran and 3 on larger ships. It was something Julie could do without too much effort. One cruise was to Alaska and the rest were in the Caribbean. We're trying to figure out where to go next. We're considering Cabo San Lucas and Ashland, Oregon. We may hold off for a bit until Coronavirus blows over.

There are two organizations for ALS, <u>http://www.alsa.org/</u> and <u>https://www.als.net/</u>. The ALS Association is famous for their ice bucket challenge. I'm thinking of doing it this summer. Anyone want to join me?

2020 Proposed RHYC Bylaws changes

The board is proposing the following changes to our bylaws. In order to maintain the health and longevity of the club we are proposing a change to our current membership structure as well as changes to annual dues. Annually the club is seeing increases in expenses with a net loss of members in the past 10 years (down 29% active membership since 2011). In order to keep us in the black and align us with how other clubs have structured their membership levels we are proposing the following changes: The removal of senior membership would increase our annual budget/ working capital for club expenses by about \$5000 amount without having to increase total dues as much. The ability to increase our annual dues by up to 5% without a club vote would allow us to maintain our budget.

Regarding senior membership the following bylaws changes are proposed: Article II: Membership Page 2 Section 2 Current wording is listed below.

The club shall have the following four (4) classes of membership.

Page 2 Section 2 Proposed changes are listed below.

The Club shall have the following three (3) classes of membership.

Page 2 Section 2B Current wording is listed below.

Page 2 Section 2B Proposed changes are listed below.

Section 2B Senior Membership: Senior membership may be conferred by the Board of Trustees upon an Active member who meets one of the following criteria:

Any individual member who has reached age 65 or over, has been an Active Member in good standing continuously for ten (10) years, and is a Past Commodore of RHYC. OR

Age 65 or older, has been an Active Member in good standing continuously for fifteen (15) years.

This class of membership shall be eligible to vote, may fly the Burgee and attend all Club functions. Boat ownership is not required. Senior members shall pay reduced dues equal to or half of the active dues rounder to the nearest dollar, but will pay no assessments. Qualifying members must apply to the Board of Trustees for this type of membership.

Current wording: Section 2D ...An active member in good standing who has been bestowed honorary membership may return to active or senior membership by notifying the Board and paying appropriate dues and assessments.

Proposed change: Section 2D...An active member in good standing who has been bestowed honorary membership may return to active or senior membership by notifying the Board and paying appropriate dues and assessments.

Current wording: Section 2C- Associate Membership Proposed change: Section 2B-Associate Membership Current wording: Section 2D- Honorary Membership Proposed change: Section 2C-Honorary Membership

Current wording: Section 3 A4: The committee will be comprised of a minimum of 2 Active or Senior members, one of which is a past Commodore and are not members of the board of Trustees or the investment committee. Proposed Changes: Section 3 A4: The committee will be comprised of a minimum of 2 Active or Senior members, one of which is a past Commodore and are not members of the board of Trustees or the investment committee. Page 21 Article IX: Pennants

Current wording with proposed changes are listed below:

An Active or Senior member shall be entitled to fly the Club Pennant on any vessel which the member is operating;...

Regarding secretary duties and role the following by laws changes are proposed: Page 14 Article VII: Governance

Current wording: Section E2: The Secretary shall see that minutes are taken at all meetings of the Board of Trustees and general membership, transmit them to all Board Members in a timely fashion, and make them available to any member upon request.

Proposed changes: Section E2: The Secretary shall see that minutes are taken at all meetings of the Board of Trustees and general membership, transmit them to all Board Members in a timely fashion, **post approved minutes on the website**, and make them available to any member upon request.

Regarding secretary duties and the inclusion of an AW editor the following by laws changes are proposed: Page 10 Article VII: Governance

Current wording: Section 2H: The flag officers and treasurer shall submit monthly, a written officer's report to the secretary for inclusion in the monthly newsletter.

Proposed changes: Section 2H: The flag officers and treasurer shall submit monthly, a written officer's report to the secretary or other member appointed by the commodore, for inclusion in the monthly newsletter.

Page 14

Current wording: Section E4-The secretary shall prepare, publish and distribute to the members the monthly RHYC Newsletter (Anchor Watch), which shall be the Official publication of the Club.

Proposed changes: Section E4-The secretary, or other member appointed by the Commodore, shall prepare...

Regarding general and special meetings the following by laws changes are proposed:

Page 16 Article VII: Governance Section 4-Meetings

Current wording: Section 4 E: A quorum of a general meeting shall consist of ten (10) voting members of the club and four (4) members of the Board of Trustees.

Proposed changes: Section 4E: A quorum of a general membership meeting or a special meeting shall consist of ten (10) voting members of the Club and four (4) members of the Board of Trustees.

Regarding increases in dues the following by laws changes are proposed:

Page 7 Article V: Application fees, dues and assessments

Current wording: Section 1: Annual membership dues rates will be established from time to time based on a recommendation by the Board of Trustees and approved by club members. These rates will be published to the membership each year on the membership renewal form and on Club Application forms.

Proposed changes: Section 1 Annual membership dues rates **may be increased up to 5% by the board to cover normal cost of doing business expenses.** Any increases above and beyond this amount will be established from time to time based on a recommendation by the Board of Trustees and approved by club members. These rates will be published to the membership each year on the membership renewal form and on Club Application forms.


